This agreement is made this _____ day of _____ 20___, by and between Ahna Phelps of Cornerstone Equestrian LLC ("Stallion owner") and _____ ("Mare owner") as follows:

PURPOSE:

Mare owner wishes to obtain semen form the stallion Amazing for the purpose of breeding a mare and producing a live foal.

TERMS AND TERMINATION FOR LFG CONTRACTS:

This agreement shall continue until the earlier of the following:

- the completion of the second season of breeding from this agreement date,
- a live foal is produced,
- any violations of this agreement by the mare owner and failure to correct such violations within 14 days of notice by the stallion owner,
- any violations of protocol for breeding with fresh cooled or frozen semen and failure to correct such violations within 14 days of notice by the stallion owner

MARE OWNER RESPONSIBILITIES FOR FRESH AND FROZEN CONTRACTS WITH A LFG

This mare is booked by name and the booking is valid for this mare only. Neither booking nor return privileges can be transferred without written permission by the stallion owner. This contract is non refundable.

Mare owner agrees to use the semen shipment for Amazing for the above specified mare only. If semen is used on any additional mares, the full stud fee and contract will be due immediately. In addition, no embryo transplants from the above mare using semen from Amazing are to be done without prior written permission from the stallion owner.

Prior to shipment of semen, a culture and cytology is strongly recommended to assure the mare is in sound breeding condition and free from infection. It is also recommended that the mare be vaccinated for Rhinopneumonitis at 5, 7, and 9 months of pregnancy and that the mare is kept up to date on all deworming and vaccinations. Failure to follow these protocols may nullify the LFG.

In order for the Guarantee to be valid, a pregnancy check by a licensed veterinarian must be performed at approximately 16, 28, and 60 days post ovulation. Mare owner must inform stallion owner of mare's pregnancy status no later than 60 days post ovulation to make arrangements for subsequent collections.

If mare fails to conceive during the course of the first breeding season, mare owner is entitled to a return breeding the following year. It will be the mare owner's responsibility to pay any related collection and shipping fees. If said mare is deemed infertile, mare owner may substitute another mare upon approval of the stallion owner. Stallion owner must be notified in writing by a licensed veterinarian of any infertility issues.

Mare owner assumes all responsibility for the care, custody, and control of the mare and bears all risk of loss or damage to the mare for any reason including, but not limited to death, disease, injury, infection, or otherwise.

STALLION OWNER RESPONSIBILITIES:

FRESH SEMEN:

The full stud fee of \$1550.00 is due before any semen will be shipped. The first collection is included in the stud fee. Subsequent collections are \$275.00 and must be paid before any additional shipments will be sent.

Cornerstone Equestrian LLC will provide fresh cooled semen via Little Hawk Farm in viable condition from Amazing to the mare owner's approved address or veterinarian. Stallion owner and breeding center are not responsible for any semen shipments that are damaged, lost, or delayed during transport. Semen must be administered by a licensed veterinarian on the day of delivery or the guarantees expressed in the agreement may not apply.

Collections are scheduled Monday-Friday from March 1 to August 31 with notice required the day before collection is needed. Weekend collections may be possible, however, there will be an additional charge of \$50.00. Semen requests must be made no later than 5 PM EST the day before shipment is required. Same day service is not guaranteed, but stallion owner will try to accommodate the mare owner whenever possible. For same day service, there will be a rush fee of \$80.00. Mare owner should keep stallion owner informed of the heat cycle of the mare so that we may be better prepared to have everything ready when it is needed.

Semen will be shipped overnight in a high quality disposable container, and it does not need to be returned. There is a limited number of Equitainers available as well. If an Equitainer is desired, mare owner must send a \$350.00 deposit. The Equitainer should be insured and returned within 4 days or a \$30.00 a day late fee will be assessed. Any late fees or damages incurred will be deducted from the deposit. Any remaining funds will be returned to mare owner when mare is successfully in foal, or at the conclusion of the current breeding season.

Shipping costs will be charged to the mare owner through a Federal Express account or via a credit card number provided directly to Little Hawk. Please provide us with a Fedex account number well in advance to cover shipping costs.

Should the stallion die or be unable to produce viable semen, the contract will be fulfilled using frozen semen..

FROZEN SEMEN WITH A LFG CONTRACT:

The full stud fee of \$1550.00 is due before any semen will be shipped. The first breeding dose is included in the stud fee. Subsequent shipments will be charged a lab fee of \$250.00 and must be paid before any additional shipments will be sent.

Once payments have been made and paperwork is order, Equine Reproduction Concepts will be responsible for shipping the frozen semen. Please contact them directly at (540) 937 9832 to schedule shipments.

Mare owner is expected to have a liquid nitrogen tank available for immediate transfer of the semen out of the dry shipper. Stallion owner is not responsible for damage to the semen during the shipment process. All costs related to the shipping of frozen semen are the mare owner's responsibility.

This contract is for ONE pregnancy. Any additional pregnancies obtained from the frozen semen dose will be required to pay the full stud fee of \$1550.00 immediately.

GUARANTEE FOR FRESH AND FROZEN SEMEN CONTRACTS WITH LFG:

If the mare does not produce a live foal that stands, sucks, and survives the first 30 days after birth, the mare owner shall be entitled to a return breeding within the 2 year time period. The guarantee will only apply if the stallion owner is notified within one week of the death of the foal by a licensed veterinarian with a statement of details. Collection and shipping fees will apply to the return breeding. If mare has not conceived by the end of the 2nd breeding season, mare owner may choose to extend the contract for one year for a fee of \$400.00 upon approval of stallion owner. In this case, all related expenses concerning collection, shipping, and vet fees are the mare owners responsibility.

SINGLE DOSE FROZEN SEMEN:

The full fee of \$675.00 is due before any semen will be shipped.

Once payment has been made and paperwork is order, Equine Reproduction Concepts will be responsible for shipping the frozen semen. Please contact them directly to schedule shipments. (540) 937-9832

Mare owner is expected to have a liquid nitrogen tank available for immediate transfer of the semen out of the dry shipper. Stallion owner is not responsible for damage to the semen during the shipping process. All costs related to the shipping of frozen semen are the mare owner's responsibility.

No guarantees are made in regards to achieving a pregnancy.

This contract is for ONE pregnancy. Any additional pregnancies obtained from any semen doses will be required to pay the full stud fee of \$1550.00 immediately.

No paperwork will be issued until all fees are paid. There will be a monthly charge of 2% on any unpaid balances after 30 days. Breeding certificates will be sent out upon notice of the foals birth, and upon receipt of a photo.

This contract shall not be transferred, and the laws of Allegheny County in the state of Pennsylvania shall govern the terms of this agreement.

FEES:

- \$275.00 Collection fee (1st collection fee included in Stud fee)
- \$250.00 Lab fee for frozen semen (1st lab fee included in full contract)
- \$350.00 Equitainer deposit (only if not using the disposable containers)
- \$50.00 Weekend collection fee (when possible)
- \$80.00 Same day rush fee (when possible)
